4. Test Scores
  - a. Overall 84.5 – update from internal review, Grade B
  - b. Over 95% tested
  - c. Long term goal overview – only one target met, never told the goals (replaced the AYP) based on 2015 baseline
  - d. CGR 4yr – needs to be 94.3% not 100%
  - e. Over 70% diversity
  - f. Over 42% Free and Reduced Lunch
  - g. Aiming high for the long term goals this year
  - h. Work on gap between subgroups. 91.7% growth but subgroups are lower, ranging from SWD(Students with Disabilities) 33.8 versus White 90.4
  - i. How are we addressing this gap? We need to figure out how to change up the learning to reach the different subgroups. Need to plan visit to Garinger HS where they had growth for each student.
  - j. How are we trending? Up, Not growing fast enough
  - k. Is the PTO involved? Answer is yes
  - l. Title IX training completed for all of the school
  - m. This Wednesday is for Digital Citizenship Training, lesson plans for each period on the early release day.
5. School Improvement Plan Draft
  - a. Move Biology CCR to 74% or higher; close proficiency gap
  - b. Move 8<sup>th</sup> grade Science CCR to 79%
  - c. Close proficiency gap by 25% between African Americans and White
  - d. Are there incentives in place? Intrinsic motivation
  - e. NC Check-ins (Math and ELA) and MAP testing, at HS we are using benchmark tests and common assessments, reach teacher for Math 8 and Math I;

- f. Adding survey for students to get feedback
  - g. Tutorial blocks – waiting on delivery for middle school, tweaking for High School; need to get approval from Central Zone 2
  - h. Meeting with CMS Science Facilitator to determine how the scores are based – June
  - i. Reminder that there is no academic qualification; acceptance based on audition
